

Series 2005 Notice of Race

This Notice constitutes Part I of GSC Sailing Instructions.

A. The Grapevine Sailing Club Is Pleased to Announce the 2005 Series Racing. The International Sailing Federation (ISF) Racing Rules, the prescriptions of the U.S. Sailing Association as revised in 2005, will govern all races. All vessels shall sail under these sailing instructions, (parts I & II) and applicable one-design class rules. The series will consist of six (6) scheduled races

B. Schedule of Events:

C. Eligibility: Open to all GSC members in good standing who have achieved this status prior to the Skipper's Meeting.

D. Fleets & Handicaps: Boats may sail as one-design if five or more are entered. Handicap fleets will be formed on the basis of rating PHRF Handicaps will be used.

E. Protest: Protest hearing will be held at Scott's landing. Protests will be handled according the procedures outlined in Part II of the sailing instructions. You must advise the race committee of your intent to protest before leaving the racecourse or your protest will not be heard.

F. Prizes:

- 1-3 Boat Fleet 1 Trophy
- 4-6 Boat Fleet 2 Trophy
- 7+ Boat Fleet 3 Trophy

G. Entry Fee for the Season Ticket: 100.00 (This will cover 2005 series racing and you will not need to fill out any more entry forms unless any changes are made)

H. Entry Fees: The entry fee for this (one) series is \$30.00
